COUNCILMAN RIVERA STATED CITY IS WORKING ON CROSSWALKS ON CHEATHAM AVE. AND SHOULD BE COMPLETED AT THE END OF THE YEAR; COMMENTED THAT A CONVERSATION ON SERVICE ROUTES IN SOUTH EAST BAKERSFIELD IS NEEDED; AND STATED THAT THERE IS AN OUDATED POLICY RELATED TO STREET LIGHTING AND IS MAKING A REFERRAL TO CITY STAFF TO ADDRESS LIGHTING.

CHAIRMAN PEREZ THANKED EVERYONE FOR ATTENDING, STATED SHE WOULD LIKE TO HAVE A COMMITMENT TO EXAMINE PEDISTRIAN FATALITIES, STRIPING, AND WORKING THROUGH SOLUTIONS, WHAT THE SOLUTIONS LOOK LIKE, HOW THEY CAN BE ACCOMPLISHED AND IDENTIFICATION OF RESOURCES.
